## Dear Evergreen MPA Program,

I am writing to very strongly recommend Andrew Buechel's application to the MPA program at The Evergreen State College. I know Andrew very well as he was an outstanding student of mine here at Evergreen during multiple programs from 2013-2016 wherein he consistently demonstrated an excellent work ethic and an outstanding understanding of the course material. Andrew was an increasingly strong student during the *Earth Matters* program in 2013-14, and was an excellent student and undergraduate researcher both in *Environmental Analysis* (2014-15; taught with a chemist and an ecologist), in *Biogeochemistry* (2016; taught with a biochemist), and during a self-directed undergraduate research project. Since his graduation from Evergreen, Andrew has been employed in the region, and his interests have shifted toward policy and public administration. At this point, based on Andrew's career plans and trajectory, I believe that Evergreen's MPA program is very well aligned with his skills and a terrific next step for him. Fundamentally, Andrew is a terrific student who is ready for graduate school-- and I firmly believe that he is very motivated and well-prepared to excel in Evergreen's MPA program.

Andrew excelled in all of my programs and most notably in my upper division programs *Environmental Analysis* and *Biogeochemistry*, both of which were very intensive and rigorous. *Environmental Analysis* was a year-long program that included a capstone research component—and Andrew turned that positive experience into an excellent research project and a conference presentation. Andrew was an exceptionally well-engaged and well-prepared student throughout all aspects of all of my programs and he was able to do this in spite of a very time-consuming off-campus job (20-30 hrs/week I believe during his time at Evergreen). He was a dedicated and enthusiastic student, displaying an excellent understanding of the upper division material that we covered in aqueous geochemistry and biogeochemistry, and consistently displaying terrific teamwork and leadership skills. Andrew took important leadership roles in group research projects and his teammates commented on the high quality of his work as well as his attention to detail. Andrew is a very strong writer and each quarter he played an integral role in helping his group produce a major research paper/presentation. His groups consistently produced excellent work, and evaluations by his fellow students indicated that he was doing more than his share and that he was a strong contributor to all facets of group projects.



Andrew took excellent advantage of opportunities to conduct research during his time at Evergreen. Andrew displayed excellent initiative in the lab during an undergraduate research project and as an excellent SURF (summer undergraduate research fellow) student in my lab during summer 2015. To be honest, based on his consistently excellent work, he would have been prepared to contribute to research at the graduate level if it aligned with his long-term interests. I strongly believe that Andrew developed transferable skills in research and writing, which in addition to his current policy-related work, have prepared him to excel in Evergreen's MPA program.

I believe that Andrew is a terrific candidate for the MPA program, not just because of the knowledge and skills he developed at Evergreen, but also because his current work related to policy (particularly with respect to non-profit) and public administration. In addition to being a consistently excellent student, Andrew collaborated exceptionally well with classmates— and these skills led me to ask him to mentor another research student.
