As an American witnessing the opiate crisis ravaging so many families, I am filled with hope. I know one family that got put back together and one individual that works tirelessly to continue making success stories. Charnay's perseverance and fight to recover drives her current work with the Tacoma Pierce-County Health Department to fight for others, and this is a testament to the programs and individuals working tirelessly to combat the crisis. I can envision the tidal wave of impact that Charnay will produce for her immediate and state-wide community with a Master's Degree in Public Administration. I am proud of Charnay's work, and I am confident her many experiences arm her with unique and powerful tools to thrive in a graduate program.

Today, Charnay is well-positioned to tackle graduate school, and she is equipped with the skills and tools needed to both succeed academically and contribute to the community at Evergreen College.
