After completing my military service, I took advantage of the Post 9-11 G.I. Bill benefits and went to study at the University of Washington in pursuit of my Bachelor of Arts in Society, Ethics, and Human

Behavior. It was this program that opened my eyes to society dynamics and ethical issues affecting diverse communities of people throughout time and today. There was one class that sparked my passion for supporting people with Intellectual and Developmental Disabilities; it was Disability in the Context of School and Society. My time in the bachelor's program laid the groundwork for my passion for social justice and equity, igniting my desire to pursue employment working with people who have Intellectual and Developmental Disabilities. Achieving my undergraduate degree was a major feat for me, as I come from a family of laborers, and I am the first person in my family to graduate high school and graduate from college. I have a passion for learning, growing, and spreading knowledge and awareness about social inequities that exist in our everyday lives.

During my undergraduate studies at the University of Washington and right before COVID-19 became widespread in 2019, I began working part-time with the non-profit organization The Arc of the Peninsula's whose mission is to "make empowerment possible." This experience provided me with firsthand insight into the power of collaboration and advocacy for individuals with developmental disabilities. When the pandemic happened in the beginning of 2020, I was promoted to Program Manager and started working full-time, while attending school full-time as well. Serving as a Program Manager and Community Inclusion Specialist, I led teams and provided goal-based services to adults with developmental disabilities. Collaborating with local nonprofits and organizations, I actively promoted advocacy and inclusion, striving to build a more equitable society. At the beginning of the pandemic, I had the wonderful opportunity to participate in the program Full Circle Meals, which delivered over 10,000 meals to individuals with developmental disabilities and their families throughout Kitsap County. Senator Christine Rolfes participated in the effort, and I was able to meet, engage, and deliver meals with her. These experiences reinforced my belief in the transformative impact of collaboration and diversity. Engaging with a diverse cohort of students and faculty in the Evergreen MPA

program will undoubtedly enrich my learning experience and broaden my understanding of the complex issues faced by different communities.

In 2022, I transitioned to a career in public service as a Management Analyst with Washington State's DSHS Developmental Disabilities Administration (DDA). After six months in this role, I was promoted to Case Resource Manager, which is my current title. Through my interactions with individuals with disabilities and their families, I developed a deep appreciation for person-centered service delivery and the importance of equitable treatment. I conduct assessments to determine the support needs of clients who have disabilities like Autism, Epilepsy, Down Syndrome. Through these assessments, clients can access services to engage in the community, accomplish goals, meet personal care needs, and successfully be a part of the work force. Honestly, this is the best job I have ever had, and I plan to continue working for the DDA until retirement. These experiences further solidified my passion for public administration and disability advocacy.

The mission of Evergreen's MPA program deeply resonates with me and draws me to the program. Its emphasis on collaborative work, diversity, and fairness and equity aligns perfectly with my personal and professional values. I firmly believe that collaborative efforts are essential in generating innovative solutions and promoting inclusive practices.
